Bidder who chooses to submit their bid electronically may download the bidding documents for e-submission from PPMO's Website www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost(as specified above) of bidding document in the Project's Antarik Rajaswa Khata as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids. 4. Pre-bid meeting shall be held at Gosaikunda Rural Municipality Office of Rural Municipal Executive Syaphrubeshi, Rasuwa at 2077/07/21, 11:00 AM.
5. Sealed or electronic bids must be submitted to the office Gosaikunda Rural Municipality Office of Rural Municipal Executive Syaphrubeshi, Rasuwa by hand/courier or through PPMO website www.bolpatra.gov.np/egp on or before 12:00 on 2077/08/5. Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 1:00PM 2077/08/5 at the office of Gosaikunda Rural Municipality Office of Rural Municipal Executive Syaphrubeshi, Rasuwa.
7. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of 2,92,000/- which shall be valid for 30 days beyond the validity period of the bid.
8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
9. Rural Municipality reserves the right to accept or reject, wholly or partly any or all the bids without assigning any reason, whatsoever.
